Previously he had worked for the Irish Business and Employers Confederation (IBEC) as an executive in their Economics, Research & Information Division. Much of this work with IBEC was concerned with the ramifications for Irish business of economic and monetary union in Europe.

Previously he worked for the European Movement which is an institution that seeks to influence the policy process and promoting public debate on EU issues in Ireland as a press officer.
