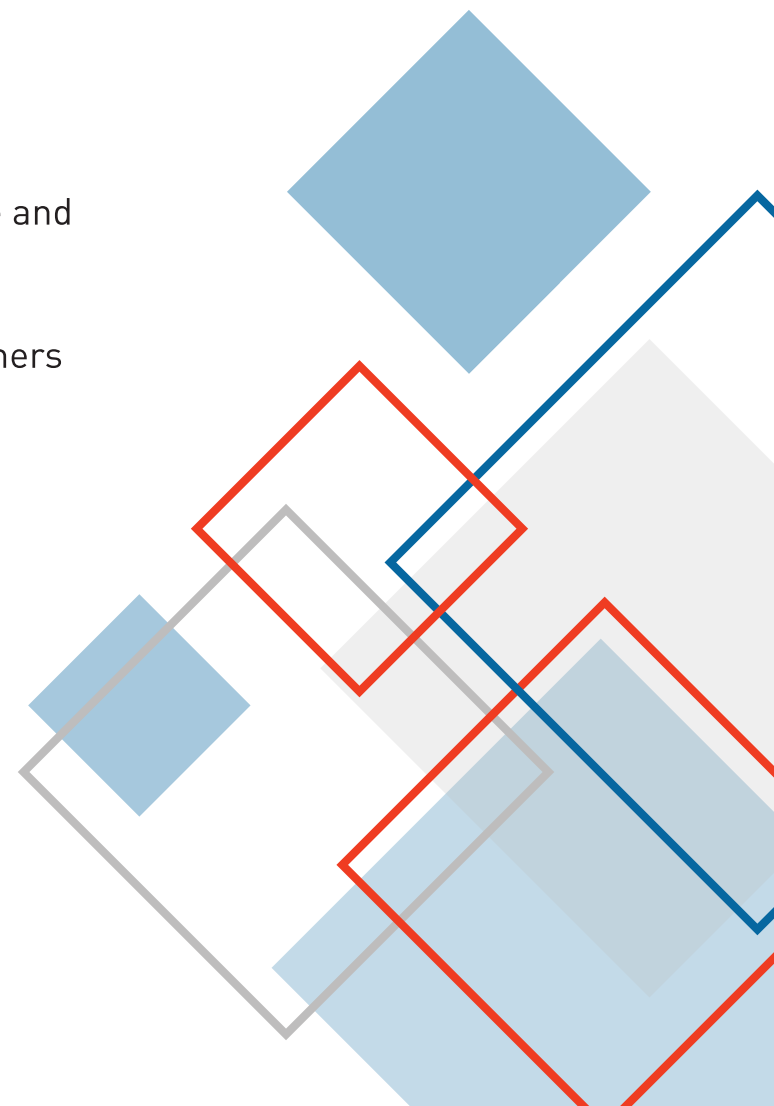
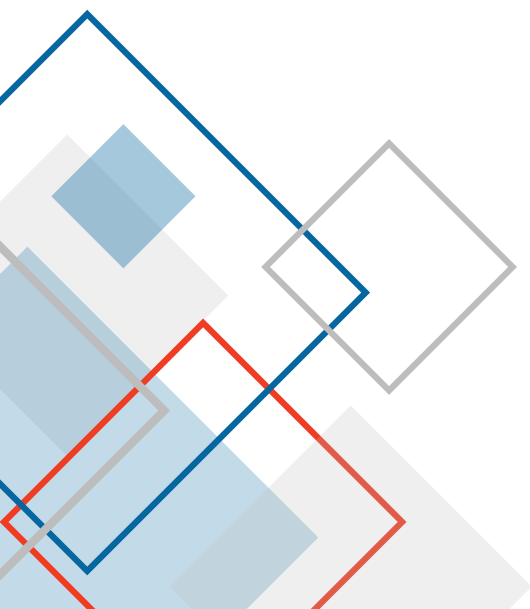
The Russian delegation will be headed by **Deputy Minister of economic development of the Russian Federation A. Gruzdev.**

- to organize high-quality contacts between potential Thailand consumers and Russian exporters - the participants of the Business mission.

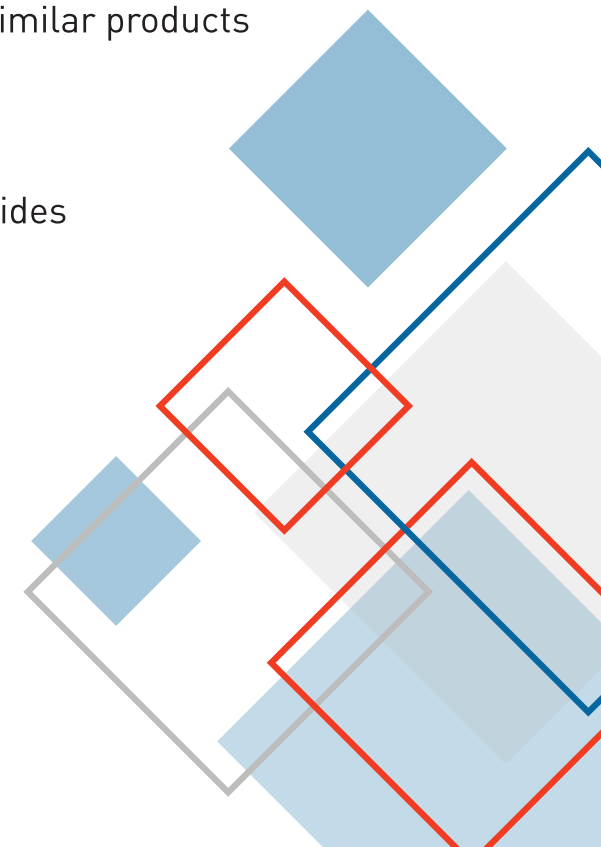
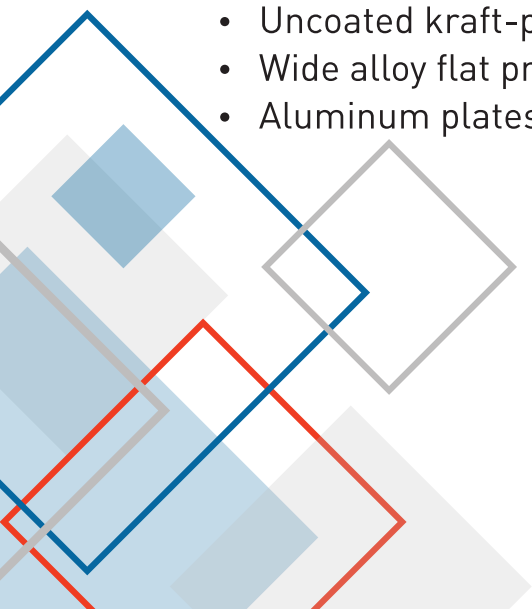
